Regulation

"Il Santo dei miracoli" is a monthly periodical sent by postal subscription – Legislative Decree No. 353/2003 of the Italian Government (converted into Law no. 46 of 27th February 2004) - art. 1, paragraph 1, NE/PD – with editorial insert and with authorization of the Court of Padova No. 11 of 28th August 1948.

The images to be published must not contain personal references that could identify illnesses, situations of hardship, or that could jeopardize the dignity or decorum of others. The photos will be published only with the indication of the name and the province and/or the State if indicated.

The images will be published in a timely manner, depending on organizational and editorial considerations.

For reasons of confidentiality and protection of personal data, the editorial staff reserves the right to evaluate the images to be published.

The editorial staff declines any responsibility regarding the authenticity and truthfulness of the information contained in the images to be published.

Information on the processing of personal data

In accordance with EU regulation 679/2016 (GDPR) and Legislative Decree 196/2003 of the Italian Government on the protection of natural persons with regard to the processing of personal data, some common personal data (name, surname, address, etc.) will be collected in order to publish images in "Il Santo dei miracoli" magazine. The data controller is Associazione Universale di Sant'Antonio, Via Cappelli, 28 - 35123 Padova (Italy), phone: +39 0498759199, fax: +39 0498759393, email: associazione@santodeimiracoli.org, Italian Tax ID code: 92028720289. Personal data will be processed exclusively to allow the publication of images as well as for the fulfilment of any legal obligations.

The processing of personal data is lawful if the person concerned (or who has parental authority) has expressed consent to the processing of their data (or of the minor).

The processing will be carried out with computerized/automated and paper/manual systems designed to store, manage and transmit the data, with logics strictly related to the purposes highlighted above, by persons specifically appointed for this purpose. Specific security measures are implemented to prevent the data from being lost, used unlawfully and/or inappropriately, and accessed without authorization.

The data will be processed by personnel appointed by the data controller and will not be communicated to third parties except to technical service providers (such as printers, postal couriers, communication agencies), computer service providers or to supervisory and control authorities in the cases provided for by law.

The period of retention of personal data of the interested party (the data subject) is strictly limited to the duration necessary for the specified purposes.

To ensure a fair and transparent treatment, we inform that:

- the data subject can obtain confirmation of the existence of personal data concerning them;
- the data subject can ask the data controller to have access to their personal data, to obtain the updating, rectification, integration or deletion of the same or the limitation or opposition to their processing, unless the data controller has a legitimate interest in their processing;
- the data subject (or who has parental authority) can revoke the consent at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation;
- the data subject can lodge a complaint with a supervisory authority;
- the provision of personal data is voluntary, but any refusal to provide such data shall carry with it the impossibility to publish the images;
- personal data will not be subject to profiling.
